## **Manuscript preparation guidelines**

Submitting an article in the journal means that its authors give their consent to publishing the article in the journal and, in case the article is accepted for publishing, its authors shall transfer to the Editor-in-chief of the journal an exclusive license for the usage of the article, in the original version and the translated version of the journal, on the basis of a License Agreement.

• Download License Agreement (PDF-file, 63Kb)

The authors are kindly asked to adhere to the following guidelines when preparing a manuscript. Deviations from these guidelines may cause publication delays.

- 1. The front page must include the appropriate AMS MSC codes, the title of the manuscript, the names and surnames of the authors, the abstract (at most 20 lines), and the keywords (at most 5 expressions). The abstract should not contain complicated formulas, references to the paper, and citations from the bibliography.
- 2. The paper should not exceed 60 pages. Longer papers can be accepted only as an exception by a special decision of the Editorial Board.
- 3. The paper should be prepared with the help of the LATEX 2e system and using the journal style file.

The submission date of the paper is the date when the paper was uploaded to the website of the journal.

- 4. Images should be prepared in one of the following standard formats: EPS, PS, PDF, TIFF, GIF, JPEG, BMP, PCX.
- 5. All items of the bibliography should be cited in the main body of the paper.
